#### Unanswered Questions about Proposed Maps

The Indiana House of Representatives Republican Caucus released draft Congressional and State House maps on September 14, 2021 as PDFs on <u>their website</u>. With only a PDF map, it is impossible to accurately assess the demographics of total population or voting age population of the proposed maps. Similarly, the PDF posted online as Proposed Amendment HB 1581 #1, is buried in the Indiana General Assembly's website and lists precincts and Census blocks corresponding to proposed districts. This means that there are no clear answers to the following questions:

- How many of these proposed districts are "majority-minority" or influence districts?
- Have communities of color been divided or packed into districts?
- Are these maps compliant with the equal protection standard as well as civil rights and voting rights laws? Do the proposed districts prevent communities of color from electing candidates of their choice?
- How will these new districts impact communities of color?

For community members to be able to analyze the maps and answer these questions, the Indiana House of Representatives must make GIS shapefiles of the proposed maps available to the public, accompanying racial demographic information regarding the proposed districts, as well as all data and estimation techniques used in the drawing of districts. The information published on September 14 falls far short of providing meaningful information or reassurance to communities of color concerned about our voting rights.

## Methodology

This document uses four sources available from the U.S. Census Bureau: American Community Survey 2006-2010; American Community Survey 2008-2012; American Community Survey 2015-2019; and the 2020 Census Redistricting Data Summary Files (P.L. 94-171). All geography summary levels displayed in these charts were available from the listed sources.
